# MEDIATION COMPETITION



## **RULES AND REGULATIONS:**

### **1. ELIGIBILITY**

1.1 Participation is open to students pursuing a full-time 3-Year LL.B. or 5-Year Integrated LL.B. course from any college or university recognized by the Bar Council of India.

1.2 Only bona fide law students with a valid identity card are eligible to participate.

### **2. TEAM COMPOSITION:**

2.1 Each team shall consist of three (03) members:

- One Mediator
- One Client & a Counsel (Pair)

2.2 Maximum 3 teams per institution shall be permitted to participate.

2.3 Cross-college teams are not permitted.

2.4 The roles of Mediator and Client–Counsel pair cannot be interchanged during the competition.

2.5 Any change in team composition must be informed to the Organizing Committee in advance and shall be subject to approval.

### **3. REGISTRATION**

3.1 All teams must complete the official registration process within the prescribed deadline.

3.2 A non-refundable registration fee of Rs. **1,200** per team shall be applicable.

3.3 Registration shall be confirmed only after:

- Submission of duly filled registration form
- Payment of registration fees
- Verification of team details

**The GENERAL INFORMATION WILL BE SHARED 72HRS BEFORE THE EVENT**

#### **4. ANONYMITY**

4.1 Teams shall not disclose their college identity to the judges at any stage of the competition.

4.2 Any violation of anonymity rules may result in disqualification.

#### **5. STRUCTURE OF THE COMPETITION**

The Mediation Competition shall be conducted in **TWO ROUNDS**:

- Round I – Preliminary Round
- Round II – Final Round

##### **5.1 Preliminary Round**

- All registered teams shall participate in the Preliminary Round.
- Each team will perform once in this round.
- Based on scores, the Top 4 Teams shall qualify for the Final Round.

##### **5.2 Final Round**

- The team securing the highest score in the Final Round shall be declared the Winner.

#### **6. MEDIATION PROBLEM**

6.1 A common mediation problem will be provided to all teams.

6.2 The problem will consist of:

- **General Information** (for all participants)
- **Confidential Information** (separate for each side)

6.3 Confidential information shall be provided 30 minutes prior to the commencement of each round.

6.4 Participants shall not introduce new facts beyond those provided in the problem.

6.5 Confidential information must not be disclosed to the opposing side outside the mediation session.

## **7. TIME STRUCTURE**

### **Preliminary Round – 40 Minutes**

- Mediation Session – 30 Minutes
- Judges' Q&A – 05 Minutes
- Scoring by Judges – 5 Minutes

### **Final Round – 60 Minutes**

- Mediation Session – 40 Minutes
- Judges' Q&A – 10 Minutes
- Scoring by Judges – 10 Minutes

7.1 Time limits shall be strictly enforced.

7.2 No additional time shall be granted.

7.3 Use of mobile phones, internet, or electronic devices is strictly prohibited.

## **8. CAUCUSES**

8.1 A maximum of one caucus per team shall be permitted in each round.

8.2 During caucuses or breaks, participants shall not communicate with any third party.

8.3 Time shall continue to run during caucuses.

## **9. EVALUATION CRITERIA**

Teams shall be evaluated on the following parameters:

## **3. MODE OF COMPETITION**

## **4. ROUNDS**

i. *The competition shall be conducted in two rounds:*

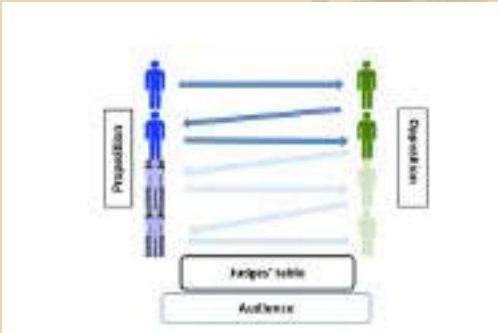
- **Preliminary Round**

ii. *In the Preliminary Round, each participant shall be allotted 5 minutes to speak.*

iii. *In the Final Round, each participant shall be allotted 7 minutes to speak.*

iv. *At the end of each round, a Rebuttal Round of 2 minutes shall be conducted for the entire group, during which both sides may present rebuttals.*

- v. No interruptions shall be allowed during the speech of any participant.
- vi. Personal remarks, derogatory comments, or offensive language against individuals, institutions, or communities are strictly prohibited.
- vii. The medium of the debate shall be English only.
- viii. Participants must adhere strictly to the allotted time; exceeding the time limit may lead to penalty or disqualification, as decided by the judges.



- ix. The decision of the judges shall be final and binding.

## TOPIC:

### **"THE DIGITAL PAYMENT USER (PROTECTION) ACT, 2026"**

#### **RULES AND REGULATIONS:**

##### **1. ELIGIBILITY FOR PARTICIPATION**

The competition is open to students currently pursuing a Law Degree (3 Year LL.B. / 5 Year LL.B.) from any recognized law college or university. Only institutions recognized by the Bar Council of India (BCI) are eligible to participate. Participation is strictly restricted to bona fide law students.

##### **2. TEAM COMPOSITION**

- The competition shall be conducted on an individual basis.
- Each college may send a maximum of 5 participants.
- Multiple entries from the same institution are permitted.

##### **3. REGISTRATION PROCEDURE**

All interested participants must complete the official registration process within the prescribed time. Registration shall be done through the Registration Form provided by the organizers. The duly filled registration form must be submitted to the organizing committee on or before the given deadline.

##### **4. REGISTRATION FEES**

- A registration fee of **Rs. 300** per participant shall be applicable.
- The registration fee must be paid at the time of registration as per the instructions provided by the organizers.
- Registration fees, once paid, shall be non-refundable under any circumstances.



## **5. CONFIRMATION OF PARTICIPATION**

1. Participation will be confirmed only after:
2. Submission of the registration form
3. Verification of student identity (Institution ID Card)
4. Completion of all formalities on the day of the event
5. Participants must report at the venue at least 40 minutes before the event.

Many citizens, especially senior citizens and first-time users, have become victims of phishing, fake payment links, identity theft, and unauthorized transactions. At present, there are scattered provisions under different laws to deal with such issues. However, there is no specific and comprehensive legislation that directly focuses on the protection of digital payment users and the regulation of digital payment service providers. Due to this gap, consumers often face difficulties in getting timely relief, refunds, or compensation for financial losses. With increasing digital literacy and the Government's push toward a cashless economy, it has become necessary to establish a strong legal framework that ensures transparency, accountability, and consumer protection in digital transactions. There is a growing demand for a law that clearly defines the rights of users and the responsibilities of digital payment platforms. Considering these circumstances, participants are required to draft a legislative framework to regulate digital payment services and protect consumers from online financial frauds.

### **“The Digital Payment User (Protection) Act, 2026”**

Your draft should broadly cover:

- Definitions of key terms
- Rights of digital payment users
- Duties of digital payment service providers

- Complaint and grievance redressal mechanism
- Offences and penalties
